#### FOREIGN RESIDENCY REQUIREMENT

Global Business students must complete a Foreign Residency Requirement, by completing one of the following:

1. An individual business internship (GBM 495: Global Business Experience)
2. A foreign study experience at the university-level of at least one semester in duration.
  - Students considered by the CSU to be “international (foreign) students” satisfy this requirement through the CSUSM residence requirement. However, all students, including international, must still take BUS 495 or GBM 495.
