## A. From Memorandum of Understanding

# **Under CSSA Autonomy**

"CSSA governing board shall maintain autonomy from the CSU Chancellor's Office in the stances it takes, the work it carries out through its governing board and contracted employees, and in accordance with its mission, values, and constitution to the extent permitted by applicable laws and CSU policies that are applied to comparable auxiliary organizations"

### B. From Personnel Policy and General Guidelines

Under I Background, Section b.

"All employees work solely for the CSSA, and are ultimately accountable to the CSSA Board of Directors. In order to provide an attractive employment package and to ensure efficient personnel processes, CSSA maintains a contractual agreement with the CSU Office of the Chancellor that requires CSSA employees to be classified as state employees."

## B. From Executive Director's Annual Performance Evaluation Policy

### **Under I Background and Purpose**

"Employees of the Chancellor's Office who are assigned by the Chancellor's Office to provide services to CSSA will report to their Chancellor's Office appropriate administrator, including the Executive Director, who reports to the Director of Student Programs, Student Academic Support, Academic Affairs, Office of the Chancellor."

### C. From CSSA Constitution Approved with Revisions May 6, 2018

Under Article III Organizational Structure, Section C Executive Officers, g.

"Is authorized to perform personnel related duties outlined in Article IV.B. of the CSSA Constitution"

Article IV: CSSA Auxiliary Obligations and Relationships, Section B. Personnel Reporting Relationship, Biannual Review, and Evaluation

## \*\*D. From CSSA Membership Policy Review

"The CSSA Membership Policy of 2018-19 states under Article III, Section B 'Campuses that do not submit a Voter Designation Form shall not be afforded the privileges given to voting members. These privileges, under the discretion of the Chair of the Board, include motioning legislation currently on the table for a vote, speaking on items outside of public comment, or sponsoring legislation.'

It is currently under the CSSA Constitution and Membership Policy that membership within committees and the Board of Directors must be comprised of voting members to campuses that designate a voter through the Voter Designation Form.

However, it is within CSSA's responsibility to ensure that the voices of elected special officers are protected and given the same platform as their respective board members. CSSA currently covers the travel expenses of special officers in regard to their role, but not their attendance to CSSA plenary meetings.

Under the Civic Engagement Officer, the Academic Senate Liaison, the Alumni Council Liaison, and Sustainability Officer position description, each position (under a different line) states the following: 'are authorized to attend monthly CSSA plenary meetings,'

We recommend for the implementation of a potential accountability measure in which board members must submit written reports prior to each plenary meeting. By doing so, elected voter designees are held accountable not only for their attendance but their dissemination of CSSA matters to their campuses, and vice versa."

# A. From the Committee on Education and the Workforce (REP) (not attached)

"The Promoting Real Opportunity, Success, and Prosperity through Education Reform (PROSPER) Act as passed by the Committee on Education and the Workforce will help more Americans earn a lifetime of success by:

- Promoting innovation, access, and completion;
- Simplifying and improving student aid;
- Empowering students and families to make informed decisions; and
- Ensuring strong accountability and a limited federal role."

# A. From the Education & the Workforce Committee (DEM) (not attached)

"The Aim Higher Act – which ensures every student has a path to a debt-free degree or credential that leads to a rewarding career. The Aim Higher Act invests in students. It makes higher education more affordable today and addresses the rising cost of college to reduce the burden on students in the future.

## The Aim Higher Act:

Makes college more affordable today – by investing in federal student aid – and helps states make public college tuition more affordable in the future – by incentivizing states to reinvest in higher education,

Cracks down on predatory for-profit institutions that target students and veterans with expensive, low-quality programs,

Protects and expands the Public Service Loan Forgiveness program, which is eliminated under the GOP PROSPER Act, and makes student loans simpler and easier to repay, Provides students the tools they need to graduate on time with a quality degree, Invests in teachers and strengthens training for teachers and school leaders to improve the quality of our schools."

# B. From Congress.GOV Bill Summary (not attached)

"College for All Act of 2017

This bill amends the Higher Education Act of 1965 (HEA) to establish a grant program to eliminate tuition and required fees: (1) for all students at community colleges and two-year tribal colleges and universities, and (2) for working- and middle-class students at four-year public institutions of higher education (IHEs).

Additionally, the bill amends title IV (Student Assistance) of the HEA to:

- reauthorize the Federal TRIO Programs, the Gaining Early Awareness and Readiness for Undergraduate Programs (i.e., GEAR UP), and the Federal Work Study Program for FY2018-FY2027;
- eliminate existing base guarantees of Federal Work Study funds to IHEs and require funds to be allocated based solely on the aggregate need of the institution's students;
- modify the interest rate formulas for federal student loans to revise applicable rates on new loans disbursed on or after July 1, 2017; and
- allow student loan borrowers to modify interest rates on outstanding federal student loans to current rates.

Finally, it directs the Department of Education to use any excess revenue generated by the Federal Direct Loan program to carry out the Federal Pell Grant program."

# B. From Bill Summary found at govtrack.us (not attached)

"Part J

# Debt-Free College Partnership

Sec. 499A-1.Purpose

The purpose of this part is to establish State-Federal partnerships that will—

- (1) increase investment in public higher education; and
- (2) provide students the opportunity to attain higher education at in-State public institutions of higher education without debt (debt-free college)."

# D. From California Undocumented Higher Education Coalition

"The California Undocumented Higher Education Coalition is composed of educators, civil rights, business, philanthropy, students, and community-based groups working to strengthen California's workforce and economy by ensuring college access and success for undocumented youth in the state. A conservative estimate finds that California's public higher education segments enroll approximately 75,000 undocumented students."

### E From Bill Summary found on booker.senate.gov (not attached)

"Currently, Title IV of the Higher Education Act mandates that institutions of higher education make a "good-faith effort" to distribute voter registration forms to students. However, this language is ambiguous and does not include an enforcement mechanism to ensure compliance.

The Help Students Vote Act would require institutions of higher education to make a good faith effort to distribute voter registration forms to each student at least twice a year by:

- Sending an email twice a year, and no less than 30 days before voter registration deadlines for federal and state elections, with links to voter registration information.
- Designating a staff member or office as the "Campus Vote Coordinator" to answer student questions about voter registration.

## The Help Students Vote Act would also:

- Authorize Fund for the Improvement of Postsecondary Education (FIPSE) grants to be awarded to institutions of higher education that greatly exceed the requirements to promote political engagement.
- Authorize the Attorney General to empower the appropriate state law enforcement officer to commence a civil action if an institution engages in a pattern of violating this law.

Provides a private right of action for individuals or groups who are aggrieved by an
institution that has engaged in a pattern of violating this law.

The Help Students Vote Act has been endorsed by more than 60 organizations"

## F. From Student Level Data Network - What it is & isn't

### "Student Level Data Network

- A Student-Level Data Network (SLDN) would connect information that is mostly already collected by colleges, governments, and employers, to answer critical questions about how different students fare at different programs. Bipartisan and bicameral legislation like the College Transparency Act would create such a network and begin to answer these questions. The information would:
  - Empower students to make more informed choices about where to invest their time and money.
  - Align college programs with workforce demands and help employers recruit new workers.
  - o Spend federal and state taxpayer money more efficiently.
  - Potentially reduce onerous reporting burden for schools and improve student success.

#### Student Agenda for Postsecondary Data Reform

- The Student Agenda for Postsecondary Data Reform synthesizes and elevates students'
  calls to action to improve how the United States collects and uses data in our higher
  education system. To keep the student perspective at the heart of higher education
  reform, policymakers should adopt the following agenda, sourced from young adults
  across the country, to meet the needs of today's students and tomorrow's workforce.
  - More and Better Data
    - Overturn the Student Unit Record Ban
    - Expand information about college majors and programs
    - More information about alternatives to traditional higher education
    - Count all of us
  - o Responsible Data Use and Access
    - Data should enhance choices, not restrict them
    - Personal information can and must be protected
    - Data should be accessible for students on campus"
