12 Discussion

Status of Vice President of Student & University Affairs Description: Due to Article 10, Section 6 of the ASI Bylaws, BOD must consider the membership of Michelle Tran being unable to fulfill job requirements.

Fiscal Impact: No

Presenter reviewed article 10 section 6-6.1.2 of ASI bylaws and clarified Michelle's violation is a result of conceding her voting rights to Kenny. Article 24 was discussed in regards to the hiring process that would take place if Michelle was removed from her position. Kenny explained the process revolving around this issue insofar. The process goes as follows: the last IO meeting it was recommended to the board to keep Michelle Tran in their position. As today's action item moved to a discussion item, the board will vote next BOD meeting as to whether or not Michelle stays in her position.

Discussion focused on process and length of removal and approval process. Committee overviewed application and interview process who is on the interviews. From that point during the next BOD meeting the recommended candidate would be brought for approval.

Discussion moved to review of CSSA bylaws. Clarification was made that Michelle is not violating any CSSA laws, she Emphasized that this has happened in practice before and reiterated the only bylaws being violated are those from ASI. Suggested to the board to consider the rehiring process and offered their services in retraining their replacement. Clarification was made on handouts to Board members. Further discussion was on members' duties to attend meeting and vote at CSSA.

Further discussion focused on conflict of interest being in both positions. Questioned why Michelle applied to both from the beginning and this is not unforeseen. It is not your inability to do the work it is a violation of the bylaws. Other members stressed the need for accountability and emphasized the confusion and lack of information amongst the board.

Further clarification focused on discussing and talking prior to board meetings one on one to better understand and ask questions. Further discussions focused on workload is for the execs, ASI president to representation in the position, and timeline of events. Further concerns focused on BOD training should have been more focused on procedural teachings rather than personality compatibility methods and tests. The chair clarified to the BOD they were informed of having 72 hours to discuss the agenda and that it was taught in the BOD training slides

Presenter highlighted that this is a learning process. Stressed the importance and benefits of personality tests and learning to work with one another and also said that they recognize there are areas of growth for the BOD training process. Others emphasized the importance of both and knowing how to do their job to support students. There is a need to learn more technical stuff to increase job proficiency. But others mentioned the importance of personality tests as the board was currently 'yelling' at one another instead of understanding each other's forms of communication and considering that when having a calm rational discussion.

Conversation shifted back to agenda item.

Concerns focused on detrimental to students to have to replace Michelle then to allow her to continue in her position and also reminders that the board represent students and need to keep students best interest in mind.

Further discussion focused on impact of interview process, focus on serving students, and the consequences of violating Bylaws.

We discussed a creation of a set of guidelines for the university regarding any program changes and how to communicate that to students effectively. Ian Chan, the chair of the committee, created some pretty vague guidelines, and we will be discussing them further at the next meeting. We also discussed the definition of what a "program change" entails. Our definition included, any changes to a degree requirement, class enrollment sizes, changes, requirements, etc., as well as any course requirement changes.

The next half of the meeting we spent discussing the election or selection of a subcommittee to create a policy for how the UPD handles any forcible removals or critical incidents. The committee discussed suggesting to EC that we are not really in a

place to be creating a policy for people when we have no credibility. I think if we're conducting research and evaluating students and faculty on how they want these situations handled, we need subcommittee members that have the knowledge to weigh in I suggested involving a representative from UPD, as well as a Diversity and Inclusion Rep from BOD. Ian will be taking these concerns to the next EC meeting. Our final thoughts on this issue are the committee needs to be elected to take the necessary steps in completing this policy. We cannot be tasked to create a policy when we do not have credibility in that area.
