- 13% tuition discount from CSUSM

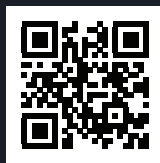
ELIGIBILITY CRITERIA

- Meet the ADN/RN to BSN program admission criteria
- Must maintain continuous enrollment
- Maintain a minimum cumulative GPA of 3.0 (on a 4.0 scale)
- Agree to work for a county hospital for two years after completion of the program

APPLICATION PROCESS

STEP 1: Visit www.csusm.edu/el/kaiser to review the application.

STEP 2: Submit your scholarship application. Your scholarship application may be submitted as part of your ADN/RN to BSN program application or it may be submitted via email to el@csusm.edu.

FORGIVABLE LOAN

This forgivable loan is available **only for Kaiser employees** interested in the ADN/ RN to BSN, MSN or Post-MSN programs.

- Forgivable loan amounts:
 - ADN/RN to BSN: up to \$5,000
 - MSN: up to \$10,000
 - Post-MSN: up to \$10,000
- 13% tuition discount from CSUSM

WHAT IS A FORGIVABLE LOAN?

In general, a forgivable loan allows you to borrow money without having to pay it back provided you meet the loan criteria.

To have the IONE loan forgiven, students must:

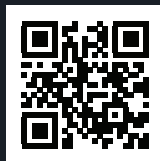
- Meet program admission criteria
- Maintain continuous enrollment
- Maintain a cumulative GPA of 3.0 or higher throughout the program
- Agree to work for Kaiser for two years after completion of the program

APPLICATION PROCESS

STEP 1: Visit www.csusm.edu/el/kaiser to learn more about the Kaiser IONE Forgivable Loan.

STEP 2: Obtain an employment verification letter from your HR department detailing your full-time status.

STEP 3: Submit your forgivable loan application and upload your employment verification as part of your nursing program application, OR complete the forgivable loan application (with your employment verification letter) on the Kaiser IONE website listed in Step 1 above.
