



Process for Student Injuries/Accidents/Illness Sustained While on Clinical Rotation 2016-2017

This process applies to CSUSM School of Nursing students.

- Contracted Clinical Placement Sites: Students at contracted placement sites (UCSD/Tri-City/Kaiser) are treated as University employees under worker's compensation if they sustain an injury/accident/illness while on their clinical rotation.
 - Notify Denise Boren (dboren@csusm.edu or 760-703-2872) and Kathleen Winston (kwinston@csusm.edu or 760-750-7557)
 - The student needs to submit a Worker's Compensation Form (DWC-1) and a Worker's Compensation Intake Sheet to Sue Belt within 24 hours of the incident.
 - The clinical faculty member needs to submit a completed Accident, Injury, or Illness – Initial Investigation (IIPP-5) form to Sue within 24 hours of the incident.
 - The student should be treated by the contract hospital and payment for treatment will be processed through worker's compensation once the claim is filed by the student.
- Non-Contracted Placement Sites: Students at all other placement sites should seek immediate medical treatment through their own personal physician or the nearest hospital (using their own health benefits).
 - Notify Denise Boren (dboren@csusm.edu or 760-703-2872) and Kathleen Winston (kwinston@csusm.edu or 760-750-7557)
 - The clinical faculty member needs to submit a completed Accident, Injury, or Illness – Initial Investigation (IIPP-5) form to Sue Belt within 24 hours of the incident.

Process for Faculty Injuries/Accidents/Illness Sustained While on Clinical Rotation 2016-2017

This process applies to CSUSM School of Nursing faculty. Faculty working on University time at a clinical placement site are covered under the University's worker's compensation.

- During Hours Occurrences
 - Notify Denise Boren (dboren@csusm.edu or 760-703-2872) and Kathleen Winston (kwinston@csusm.edu or 760-750-7557)
 - Complete a Worker's Compensation Form (DWC-1) and a Worker's Compensation Intake Sheet and send to Sue Belt within 24 hours of the incident.
 - For emergency medical treatment, proceed to the nearest hospital emergency room. For non-emergency treatment, contact Safety Risk and Sustainability at 760-750-4502 to authorize your visit prior to your arrival at the occupational medical provider.
- Afterhours Occurrences (after 5pm M-F, weekends, holidays, campus closure days)
 - Notify Denise Boren (dboren@csusm.edu or 760-703-2872) and Kathleen Winston (kwinston@csusm.edu or 760-750-7557)
 - Complete a Worker's Compensation Form (DWC-1) and a Worker's Compensation Intake Sheet and send to Sue Belt within 24 hours of the incident
 - For emergency medical treatment, proceed to the nearest hospital emergency room. Refer the hospital emergency room to the Worker's Compensation Coordinator at 760-750-4505 for billing information. For non-emergency treatment, please proceed to one of the campus' occupational medical providers (see list on next page).
