



Indian Health Services Loan Repayment Program

Applicants sign 2 year contractual agreements and fulfill their agreements through full-time clinical practice at an Indian Health Service facility or approved Indian health program. In return, the Loan Repayment Program will repay all or a portion of the applicant's eligible health professionals educational loans (undergraduate and graduate) for tuition expenses. Applicants are eligible to have their educational loans repaid in amounts up to \$20,000 per year for each year of service.

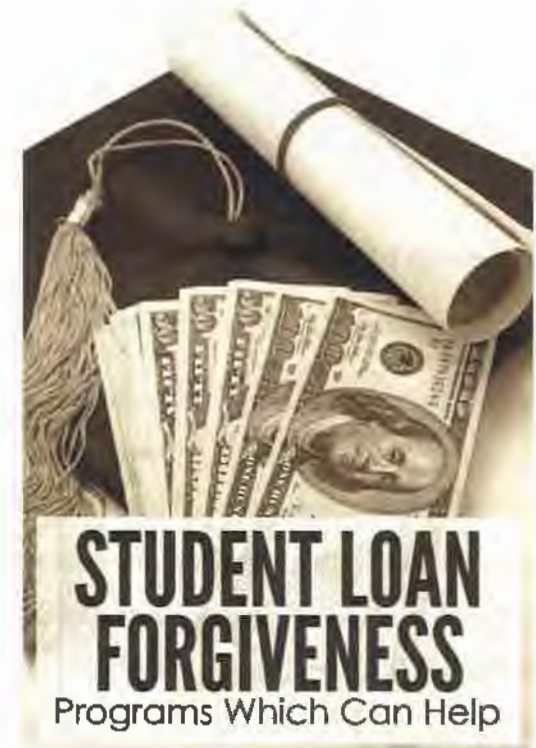

National Health Service Corps Loan Repayment Program

This program is open to licensed primary care medical, dental, and mental and behavioral health providers who are employed or have accepted an offer of employment at an NHSC-approved site. Awardees receive up to \$50,000 in exchange for two-years of service if they practice in a Health Professional Shortage Area (HPSA) of 14 and above (Tier I) or up to \$30,000 in exchange for two-years of service if they practice in a HPSA of 13 and below.

Mental Health Loan

Assumption Program (MHLAP)

An award recipient may receive up to \$10,000 to repay educational loans in exchange for a 12-month service obligation in a hard-to-fill or retain position within the County Public Mental Health System.

Licensed Mental Health Services Provider Education Program (LMHSPEP)

An awardee may receive up to \$15,000 to repay educational loans in exchange for a 24-month commitment to practicing and providing direct care in an eligible facility or shortage area.

Public Service Loan Forgiveness Program (PSLF)

The Public Service Loan Forgiveness Program is intended to encourage individuals to enter and continue to work full-time in public service jobs. Under this program, borrowers may qualify for forgiveness of the remaining balance of their Direct Loans after they have made 120 qualifying payments on those loans while employed full time by certain public service employers.
